This Memorandum of Understanding (MOU) sets for the terms and understanding between Shri Rawatpura Sarkar University, Raipur (Chhattisgarh), India (PARTY A) and IICCI BANGLADESH (PARTY B)

For the purpose of providing services and students to Signed on Date 17/04/19 at Delli India.

The above goal will be accomplished by undertaking the following activities:

1. Party A authorize Party B as their approved Marketing Agent to provide admission on their behalf to study in regular campus at Raipur (Chhattisgarh) India.
2. Party B will provide International Students to Party A for all of their existing Courses as per the eligibility criteria according to different courses.
3. Party A authorizes Party B to appoint the sub agents in different areas and share the revenue commission out of the total commission being payable to them by Party A.
4. Party B will collect copy of the certificate of passed education of the candidate on basis of which on the spot provisional admission will be provided . The university will have 30 days to verify and reject admission of the candidate. Any admission rejected after 30 days will be liable to the commission as per the regular business norms because the only rejection can be on the basis of some merit not approved by Government of India.
5. All the merits and eligibly criteria laid down by Government of India/ university are to be informed accordingly and followed by Party B for admission in.

6. The advertisement material such as prospectus/ flyers will be provided by the university in reasonable quantity.
7. Party A will assign a specific admission Officer who instruction will be abided by Party B as main approved guidelines by the university.
8. The selection criteria for student for Party B is on the basis of academic record and not the social economic strength of the family and the commission payment of Party B should not be related to any other aspect .
9. Remuneration/Commission will provide of INR 8000/- per student, No. of students should be admitted between 01 to 10), INR 10000/- per student will provide, No. of students should be admitted more than 10.
10. Party A will not contact any employee of Party B or any of their Sub Agent for getting direct business.
11. Every month in the first/second week the account of last month accounts will be tallied and cleared regularly. Remuneration/Commission will be paid after the complete tuition fee of 1st year has been paid by the student.
12. Party B will not collect any fees from the students in cash. All fees will be collected by Cheque/DD/Bank Transfer in the account of Party A only.
13. If any student(s) drops out from the course for any reason by paying partial fee / full fee of the first year. In such cases commission cannot be payable to Party B or paid commission will be adjusted.

Duration

This MoU is at-will and may be modified by mutual consent of authorized officials. This MoU shall become effective upon signature by the authorized officials and will remain in effect until modified or terminated by the partner(s) with mutual consent. Both parties can terminate this MoU after giving 01 month notice and after settlement of accounts. All dispute and jurisdiction are subject to Raipur (Chhattisgarh), India Jurisdiction.
