Sir,

This has reference to the proposal submitted by the University for 12-B status and subsequent visit of the UGC Expert Committee on 10-11th April, 2021 to consider the proposal. The Report of the Expert Committee alongwith the compliance submitted by the University was placed before the Standing Committee of UGC members for consideration. The Committee recommended as under:-

"The Committee considered the report of the UGC's Expert Committee along with the compliance submitted by the University.

The Committee decided to recommend approval of 12 B status to Shri Rawatpura Sarkar University, NH-30, New Dhamtari Road, Post- Mana, Raipur-492015, Chhattisgarh (Private University).

The University is advised to participate in NIRF ranking and get NAAC accreditation at the earliest.

The faculty sanctioned and in position should be as per concerned statutory council(s)/ UGC norms in all the Departments."
