The following business was transacted:

At the outset, the vice chancellor extended a warm welcome to the members then requested Registrar, the member secretary to take up the agenda one by one.

Agenda-1: Confirmation of the minutes of the last Meeting of Academic Council held on 7th June' 2024.

Resolution:	The member secretary read out the minutes of the last meeting of Academic Council and it was confirmed by the members of the council.		
Agenda-2:	Action Taken Report on the decisions taken in the previous meetings.		
Resolution:	The member secretary apprised the house, the outcome of the action taken by the concerned authorities/officers on the decisions made in the previous meetings. The members expressed their satisfaction over the action taken.		
Agenda-3:	Review of the preparation of third Convocation proposed to be held on 20th September 2024.		
Resolution:	The Third convocation of the university was likely to be held on 20th September 2024 and the request letter to the His Excellency, the Governor of Chhattisgarh had		

been sent for obtaining his assent and the final date of convocation. He urged upon the members to extend their help to organise this convocation in a grand and befitting manner.

Agenda-4:

To pass the grace on the candidates eligible for the award of Diploma and degrees at the third convocation of the University proposed to be held on 20th September 2024.

Resolution:

The controller of examinations presented a list of candidates, who were found qualified for their respective diplomas and degrees in the academic sessions 2023-2024. The members, after having gone the list, unanimously resolved to recommend that the diplomas and degrees be conferred on and the grace be passed on all the candidates, whose names figured in the list, at the third convocation of the university.

Agenda-5:

To consider and propose the names of the persons for conferment of D.Litt/ D.Sc (Honoris Causa) at the third convocation of the University.

Resolution:

Following six names, received from the faculties were placed before the members of the academic council for consideration and approval:

Education of the university.

Further, it was resolved from the academic session 2024-25, the programmes B.Ed, B.P.Ed, BPES, MPES, D.El.Ed (Special Education), and B.Ed (Special Education) will run under the faculty of Education as specified in the University's Ordinance 2022

Agenda-7:

Resolution

Due to the demand, the faculty of law and its board of studies proposed to start offering one-year LLM programs in the forthcoming session.

It is resolved that the proposal to offer the one-year LLM program may be taken into consideration in accordance with UGC guidelines/directives (wide letter D.O. No. 5-1/99 (CPP-II), Dated 18 Jan 2013).

Further resolved that the registrar be asked to take necessary steps for the purpose including the amendments in the university statute/ordinance.
